FINAL ORDER APPROVING AMENDMENT TO PARI-MUTUEL WAGERING OPERATING LICENSE

Pursuant to the provisions of section 550.01215, Florida Statutes, and the rules promulgated thereunder, the Florida Gaming Control Commission ("Commission") is responsible for the investigation and prior approval of applications and amendments to applications for parimutuel facilities; and

Gulfstream Park Racing Association, Inc. d/b/a Gulfstream Park Racing and Casino ("Gulfstream Park") possesses a valid thoroughbred permit. Gulfstream Park has been issued a pari-mutuel wagering operating license for the 2023-2024 Fiscal Year. Gulfstream Park's current operating license includes 162 performances (157 matinee and 5 charity). Now, Gulfstream Park has applied for an amended operating license canceling one matinee performance, resulting in a new schedule of 161 performances (156 matinee and 5 charity).

The Commission has received and reviewed the pertinent records and supporting documentation concerning Gulfstream Park's amended application for a pari-mutuel wagering operating license and after proper consideration thereof,

NOW, THEREFORE, be it known that:

Pursuant to the requirements of section 550.01215, Florida Statutes, the Commission hereby approves this amendment to Gulfstream Park Racing Association, Inc.'s pari-mutuel wagering operating license.

This final order is issued nunc pro tunc to April 3, 2024.
