FINAL ORDER

The Department of Business and Professional Regulation,
Division of Pari-Mutuel Wagering (hereinafter "Petitioner")
issues this Final Order against BILDONIO FERNANDEZ (hereinafter
"Respondent") as follows:

- 1. An Administrative Complaint was filed in this case on June 28, 2016, alleging that Respondent violated certain provisions of chapter 550, Florida Statutes. A copy of the Administrative Complaint is attached hereto as Exhibit A.
- 2. The Administrative Complaint, Election of Rights form, an Explanation of Rights, and cover letter were mailed to Respondent via Certified U.S. Mail on both July 11, 2016 and December 27, 2016 to Respondent's last known address. Additionally, a copy was sent via First Class U.S. Mail on December 27, 2016. Proof of mailing by Certified and Regular U.S. Mail is attached hereto as Exhibits B, C and D.

- 3. On or about December 27, 2016, Petitioner served Respondent the Administrative Complaint, Explanation of Rights, and Election of Rights Form via First Class U.S. Mail to Respondent's last known address.
- 4. The Election of Rights form, Explanation of Rights, and cover letter informed Respondent that a written response to the Administrative Complaint, including the right to request a hearing, was due within 21 days of actual service of the Administrative Complaint. See section 120.569(1), Florida Statutes, and rule 28-106.111, Florida Administrative Code.
- 5. Petitioner made all reasonable efforts to provide actual notice to Respondent.
- 6. Petitioner informed Respondent that the failure to file a timely response to the Administrative Complaint may be deemed a waiver of the right to a hearing or resolution in this matter.
- 7. To date, Respondent has not submitted an Election of Rights form or otherwise provided a response to the Administrative Complaint filed and served in this action.

Having considered the Administrative Complaint, the evidence of Petitioner's reasonable attempt to provide actual notice to Respondent, and being otherwise fully advised in the premises, it is hereby

ORDERED AND ADJUDGED:

- 8. The allegations of fact and the conclusions of law in the Administrative Complaint are adopted in their entirety herein.
- 9. Respondent is hereby permanently EXCLUDED from ALL pari-mutuel facilities within this state.
- 10. This Final Order is effective on the date it is filed with the Agency Clerk of the Department of Business and Professional Regulation as indicated on the first page of this Final Order.



ADMINISTRATIVE COMPLAINT

The Department of Business and Professional Regulation, Division of Pari-Mutuel Wagering ("Petitioner") files this Administrative Complaint against Bildonio Fernandez ("Respondent") and alleges as follows:

- 1. Petitioner is the state agency charged with regulating pari-mutuel wagering and cardrooms pursuant to Chapter 550 and Section 849.086 Florida Statutes.
- 2. Respondent's lives at 431 East 64th St, Hialeah, Florida, 33013, and does not currently hold a license with Petitioner.
 - 3. Mardi Gras Casino is a licensed pari-mutuel and cardroom facility in this state.
- 4. Surveillance video from April 30, 2016, at Mardi Gras Casino showed Respondent, a patron, placing tournament poker chips in his pant pocket. Surveillance video also showed Respondent leaving the premises of Mardi Gras Casino without returning the chips.
- 5. On or about May 2, 2016, Mardi Gras Casino staff confronted Respondent when Respondent returned to the premises. Mardi Gras Casino staff was able to retrieve the poker



tournament chips from Respondent and issued Respondent a lifetime exclusion from Mardi Gras Casino.

6. Section 550.0251(6), Florida States, provides in relevant part that...

[i]n addition to the power to exclude certain persons from any pari-mutuel facility in the state, the division may exclude any person from any and all pari-mutuel facilities in this state for conduct that would constitute, if the person were a licensee, a violation of this chapter or the rules of the division. The division may exclude from any pari-mutuel facility within this state any person who has been ejected from a pari-mutuel facility in this state or who has been excluded from any pari-mutuel facility in another state by the governmental department, agency, commission, or authority exercising regulatory jurisdiction over pari-mutuel facilities in such other state.

- 7. Based on the foregoing, Petitioner has the authority to exclude Respondent from any pari-mutuel facility within this state.
- 8. WHEREFORE, Petitioner respectfully requests that the Division enter an Order permanently excluding Respondent from all licensed pari-mutuel facilities in the state.
