ADMINISTRATIVE COMPLAINT

The Department of Business and Professional Regulation, Division of Pari-Mutuel Wagering ("Petitioner"), files this Administrative Complaint against Deondre Tevorris Jackson ("Respondent"), and alleges as follows:

- 1. Petitioner is the state agency charged with regulating pari-mutuel wagering and slot machine gaming pursuant to Chapters 550 and 551, Florida Statutes.
- 2. At all times material hereto, Respondent's address of record was 13142 Port Said Road Apt. #1120, Opa Locka, Florida 33054.
- Fronton Holdings, LLC, d/b/a Casino Miami Jai-Alai, is a facility operated by a 3. permitholder authorized to conduct pari-mutuel wagering and slot machine gaming in this state under Chapters 550 and 551, Florida Statutes.
 - At all times material hereto, Respondent was a patron at Casino Miami Jai-Alai. 4.
- On or about July 23, 2018 Respondent was permanently excluded from Casino 5. Miami Jai-Alai.

- 6. Section 550.0251, Florida Statutes, provides in relevant part:
 - (6) in addition to the power to exclude certain persons from any pari-mutuel facility in the state, the division may exclude any person from any and all pari-mutuel facilities in this state for conduct that would constitute, if the person were a licensee, a violation of this chapter or the rules of the division. The division may exclude from any pari-mutuel facility within this state any person who has been ejected from a pari-mutuel facility in this state.

WHEREFORE, Petitioner respectfully requests the Division Director enter an Order permanently excluding Respondent from all licensed pari-mutuel facilities in the state of Florida, pursuant to Chapter 550, Florida Statutes, and the rules promulgated thereunder.
