#### FINAL ORDER

The Department of Business and Professional Regulation, Division of Pari-Mutuel Wagering ("Petitioner" or "Division"), hereby enters this Final Order against Asdriel Ocanto Socorro ("Respondent"), and states as follows:

- 1. An Administrative Complaint was filed in this case on September 13, 2018, alleging that Respondent is subject to discipline under the provisions of section 550.0251(6), Florida Statutes ("Administrative Complaint"). A true and correct copy of the Administrative Complaint is attached hereto as Exhibit "1" and incorporated by reference.
- 2. Service of the Administrative Complaint was attempted via certified mail on Respondent. Proof of attempted service via certified mail is attached hereto as Exhibit "2" and incorporated by reference.
- 3. Notice of this matter was served upon Respondent on February 8, 2019, February 15, 2019, February 22, 2019 and March 1, 2019, via publication in the *Miami Daily Business Review*, a publication in general circulation within Miami-Dade County, Florida ("Notice of

Action"). A true and correct copy of the Notice of Action is attached hereto as Exhibit "3" and incorporated by reference.

- 4. The Notice of Action Election informed Respondent that Petitioner filed an Administrative Complaint against him and provided instructions on how to receive a copy of the Administrative Complaint and that contact would be required to dispute the allegations within the Administrative Complaint. See § 120.569(1), Fla. Stat. and Fla. Admin. Code R. 28-106.111.
- 5. In addition, the Notice of Action informed Respondent that the failure to timely file a response to the Administrative Complaint would be deemed a waiver of right to a hearing or resolution in this matter.
- 6. To date, Respondent has not submitted an Election of Rights form or otherwise provided a response to the Administrative Complaint filed and served in this action.

Upon consideration of the facts and conclusions of law delineated in the Administrative Complaint, it is ORDERED:

- 7. The allegations of fact set forth in the Administrative Complaint are approved, adopted and incorporated herein by reference as findings of fact by the Division.
- 8. The conclusions of law alleged and set forth in the Administrative Complaint are approved, adopted, and incorporated herein by references as the conclusions of law by the Division.
- 9. There is competent substantial evidence to support the findings of fact and conclusions of law by the Division.

- 10. Respondent is hereby **PERMANENTLY EXCLUDED** from all licensed parimutuel facilities located within the state of Florida.

#### **ADMINISTRATIVE COMPLAINT**

The Department of Business and Professional Regulation, Division of Pari-Mutuel Wagering ("Petitioner") files this Administrative Complaint against Asdriel Ocanto Socorro ("Respondent") and alleges:

- 1. Petitioner is the state agency charged with regulating pari-mutuel wagering pursuant to Chapter 550, Florida Statutes.
  - 2. Respondent's address of record is 5301 E. 5<sup>th</sup> Avenue, Hialeah, Florida 33013.
- 3. Hialeah Park d/b/a Casino Miami is a licensed pari-mutuel facility and cardroom in the State of Florida.
- 4. On or about March 4, 2018, Respondent was issued a trespass warning and permanent exclusion from its facility by Casino Miami.
- 5. Section 550.0251(6), Florida States, provides in relevant part that "[i]n addition to the power to exclude certain persons from any pari-mutuel facility in the state, the division may exclude any person from any and all pari-mutuel facilities in this state for conduct that would constitute, if the person were a licensee, a violation of this chapter or the rules of the division.

The division may exclude from any pari-mutuel facility within this state any person who has been ejected from a pari-mutuel facility in this state or who has been excluded from any pari-mutuel facility in another state by the governmental department, agency, commission, or authority exercising regulatory jurisdiction over pari-mutuel facilities in such other state."

WHEREFORE, Petitioner respectfully requests the Division enter an Order permanently excluding Respondent from all licensed pari-mutuel facilities in the state of Florida.
