# FINAL ORDER ADDING RESPONDENT TO THE STATEWIDE PERMANENT EXCLUSION LIST

Pursuant to sections 550.0251(6) and 551.112, Florida Statutes, and the rules promulgated thereunder, the Florida Gaming Control Commission ("Commission"), has the power to exclude from all pari-mutuel facilities and all facilities of a slot machine licensee in the state of Florida, any person who has been ejected from a pari-mutuel facility or a facility of a slot machine licensee in this state.

An Administrative Complaint was filed on April 22, 2022, alleging that respondent was a patron at Magic City Casino and was excluded on February 1, 2022. Magic City Casino is a facility operated by a permitholder authorized to conduct pari-mutuel wagering, slot machines, and cardroom operations in the State of Florida. Respondent was served with the Administrative Complaint on June 21, 2022 and failed to respond to the Administrative Complaint within 21 days.

The Commission has received and reviewed the pertinent records and supporting documentation concerning Respondent's exclusion. At the meeting on August 4, 2022, the Commission adopted the findings of fact in the Administrative Complaint as the factual findings in this case, found that Respondent was properly served with the Administrative Complaint, found that Respondent waived his right to a hearing pursuant to rule 28-106.111(4), Florida Administrative Code, and after proper consideration thereof,

#### **NOW, THEREFORE**, be it known that:

The Commission hereby adds Respondent to the permanent exclusion list for all parimutuel facilities and facilities of a slot machine licensee within the state of Florida.

It is so ordered.

#### ADMINISTRATIVE COMPLAINT

The Department of Business and Professional Regulation, Division of Pari-Mutuel Wagering ("Petitioner"), files this Administrative Complaint against Ivan Francisco Arias Garcia ("Respondent"), and alleges:

- 1. Petitioner is the state agency charged with regulating pari-mutuel wagering, slot machines, and cardroom operations pursuant to Chapters 550, 551, and 849, Florida Statutes.
- At all times material hereto, Respondent's address was reported as 430 Southwest
   6th Street, Miami, Florida 33130.
- 3. At all times material hereto, Magic City Casino was a facility operated by a permitholder authorized to conduct pari-mutuel wagering, slot machines, and cardroom operations in the State of Florida.
  - 4. On or about February 1, 2022, Respondent was a patron of Magic City Casino.
- On or about February 1, 2022, Respondent was ejected and permanently excluded from Magic City Casino.
  - 6. Section 550.0251(6), Florida Statutes, provides in relevant part:

In addition to the power to exclude certain persons from any parimutuel facility in the state, the division may exclude any person from any and all pari-mutuel facilities in this state for conduct that would constitute, if the person were a licensee, a violation of this chapter or the rules of the division. The division may exclude from any pari-mutuel facility within this state any person who has been ejected from a pari-mutuel facility in this state or who has been excluded from any pari-mutuel facility in another state by the governmental department, agency, commission, or authority exercising regulatory jurisdiction over pari-mutuel facilities in such other state.

#### (Emphasis supplied).

7. Section 551.112, Florida Statutes, provides:

In addition to the power to exclude certain persons from any facility of a slot machine licensee in this state, the division may exclude any person from any facility of a slot machine licensee in this state for conduct that would constitute, if the person were a licensee, a violation of this chapter or the rules of the division. The division may exclude from any facility of a slot machine licensee any person who has been ejected from a facility of a slot machine licensee in this state or who has been excluded from any facility of a slot machine licensee or gaming facility in another state by the governmental department, agency, commission, or authority exercising regulatory jurisdiction over the gaming in such other state. This section does not abrogate the common law right of a slot machine licensee to exclude a patron absolutely in this state.

#### (Emphasis supplied).

8. Based on the foregoing, Respondent violated Sections 550.0251(6) and 551.112, Florida Statutes and is subject to exclusion from all licensed pari-mutuel wagering facilities and any facility of a slot machine licensee in the State of Florida based on his ejection from Magic City Casino on or about February 1, 2022.

WHEREFORE, Petitioner respectfully requests the Division Director enter an Order excluding Respondent from all licensed pari-mutuel wagering facilities and any facility of a slot machine licensee in the State of Florida, along with any other remedy provided by Chapters 550 and 551, Florida Statutes, and/or the rules promulgated thereunder.
