FINAL ORDER

This matter appeared before the Florida Gaming Control Commission at a duly-noticed public meeting on June 8, 2023, for final agency action pursuant to sections 120.569 and 120.57(2), Florida Statutes. After a complete review of the record in this matter, the Commission makes the following findings of fact and conclusions of law:

- 1. An Administrative Complaint was filed in this case on July 14, 2022, alleging that Respondent is subject to exclusion from all licensed pari-mutuel wagering facilities in the state of Florida pursuant to sections 550.0251(6), Florida Statutes. A copy of the Administrative Complaint is attached hereto as Exhibit "1" and incorporated by reference.
- 2. The Administrative Complaint, Election of Rights form, an Explanation of Rights, and a cover letter were served on Respondent via mail service on April 7, 2023. Proof of service is attached hereto as Exhibit "2" and incorporated by reference.
- 3. Petitioner informed Respondent that the failure to file a timely response to the Administrative Complaint would be deemed a waiver of the right to a hearing.

4. Respondent has not filed a timely response to the Administrative Complaint.

Respondent has not submitted any evidence or made any allegations that would support the application of the doctrine of equitable tolling.

Having considered the Administrative Complaint, the service of the Administrative Complaint with Election of Rights form, Explanation of Rights, and cover letter on Respondent along with Respondent's failure to respond, and being otherwise fully advised in the premises, it is hereby

ORDERED and ADJUDGED:

- 1. The allegations of fact and the conclusions of law in the Administrative Complaint are adopted in their entirety herein.
- 2. Respondent is hereby **PERMANENTLY EXCLUDED** from all pari-mutuel facilities within the State of Florida.

This Final Order shall take effect upon being filed with the Clerk of the Commission.



ADMINISTRATIVE COMPLAINT

The Florida Gaming Control Commission, Division of Pari-Mutuel Wagering ("Petitioner"), files this Administrative Complaint against Nathan James Brown ("Respondent"), and alleges:

- 1. Petitioner is the state agency charged with regulating pari-mutuel wagering, slot machines, and cardroom operations pursuant to Chapters 550, 551, and 849, Florida Statutes.
- 2. At all times material hereto, Respondent's address was reported as 500 West Platt Street, Tampa, Florida 33604.
- 3. At all times material hereto, Palm Beach Kennel Club was a facility operated by a permitholder authorized to conduct pari-mutuel wagering and cardroom operations in the State of Florida.
 - 4. On or about June 5, 2022, Respondent was a patron of Palm Beach Kennel Club.
- 5. On or about June 5, 2022, Respondent was ejected and permanently excluded from Palm Beach Kennel Club.

6. Section 550.0251(6), Florida Statutes, provides in relevant part:

In addition to the power to exclude certain persons from any parimutuel facility in the state, the division may exclude any person from any and all pari-mutuel facilities in this state for conduct that would constitute, if the person were a licensee, a violation of this chapter or the rules of the division. The division may exclude from any pari-mutuel facility within this state any person who has been ejected from a pari-mutuel facility in this state or who has been excluded from any pari-mutuel facility in another state by the governmental department, agency, commission, or authority exercising regulatory jurisdiction over pari-mutuel facilities in such other state.

(Emphasis supplied).

7. Based on the foregoing, Respondent is subject to exclusion from all licensed parimutuel wagering facilities in the State of Florida under Section 550.0251(6), Florida Statutes, based on his ejection from Palm Beach Kennel Club on or about June 5, 2022.

WHEREFORE, Petitioner respectfully requests the Florida Gaming Control Commission enter an Order excluding Respondent from all licensed pari-mutuel wagering facilities in the State of Florida, along with any other remedy provided by Chapters 550 and 551, Florida Statutes, and/or the rules promulgated thereunder.

Mediation under Section 120.573, Florida Statutes, is not available to resolve this Administrative Complaint.
