**FINAL ORDER APPROVING AMENDMENT TO PARI-MUTUEL OPERATING  
LICENSE**

Pursuant to the provisions of section 550.01215, Florida Statutes, and the rules promulgated thereunder, the Florida Gaming Control Commission ("Commission"), is responsible for the investigation and prior approval of applications and amendments to applications for pari-mutuel facilities; and

Tampa Bay Downs, Inc. ("Tampa Bay Downs") possesses a valid thoroughbred permit. Tampa Bay Downs has been issued a pari-mutuel operating license for the 2022-2023 Fiscal Year. When Tampa Bay Downs applied for its operating license, it included 92 performances (87 regular and 5 charity). Now, Tampa Bay Downs has submitted an amended application for a pari-mutuel operating license that adds one thoroughbred race date and deletes one thoroughbred race date for a total of 92 race dates (87 regular and 5 charity.)

The Commission has received and reviewed the pertinent records and supporting documentation concerning Tampa Bay Downs' amended application for a pari-mutuel operating license and after proper consideration thereof,


**NOW, THEREFORE**, be it known that:

SUCH PROCEEDINGS ARE COMMENCED BY FILING ONE COPY OF A NOTICE OF APPEAL WITH THE AGENCY CLERK OF THE DEPARTMENT OF BUSINESS AND PROFESSIONAL REGULATION AND A SECOND COPY, ACCOMPANIED BY FILING FEES PRESCRIBED BY LAW, WITH THE DISTRICT COURT OF APPEAL OF THE FIRST DISTRICT OR IN THE APPELLATE DISTRICT WHERE THE PARTY RESIDES. THE NOTICE OF APPEAL MUST BE FILED WITHIN THIRTY (30) DAYS OF RENDITION OF THE ORDER TO BE REVIEWED.
