Pursuant to the provisions of section 849.086, Florida Statutes, and the rules promulgated thereunder, the Florida Gaming Control Commission ("Commission") is responsible for the investigation and prior approval of applications and amendments to applications for cardrooms; and

TBD Entertainment, LLC d/b/a TGT Poker & Racebook ("TGT") possesses a greyhound permit, permit number 140. TGT has been issued a pari-mutuel wagering operating license and a cardroom license for the 2024-2025 Fiscal Year. TGT is currently licensed to operate 19 card tables and is requesting permission to add 6 card tables to its cardroom for a total of 25 tables. TGT has paid the \$6,000 license fee associated with the additional tables.

The Commission has received and reviewed the pertinent records and supporting documentation concerning TGT's amended application for a cardroom license and after proper consideration thereof,

**NOW, THEREFORE**, be it known that:

Pursuant to the requirements of section 849.086, Florida Statutes, the Commission hereby approves this amendment to TBD Entertainment, LLC d/b/a TGT Poker & Racebook's cardroom license.
