FINAL ORDER APPROVING AMENDMENT TO
PARI-MUTUEL WAGERING OPERATING LICENSE

Pursuant to the provisions of section 550.01215, Florida Statutes, and the rules promulgated thereunder, the Florida Gaming Control Commission ("Commission") is responsible for the investigation and prior approval of applications and amendments to applications for pari-mutuel facilities; and

Tampa Bay Downs, Inc. ("Tampa Bay Downs") possesses a valid thoroughbred permit, permit number 320. Tampa Bay Downs has been issued a pari-mutuel wagering operating license for the 2024-2025 Fiscal Year. Tampa Bay Downs' 2024-2025 operating license includes 91 performances (86 matinee and 5 charity). Tampa Bay Downs has applied for an amended operating license canceling two matinee performances on July 1, 2024, and June 30, 2025, resulting in a new schedule of 89 performances (84 matinee and 5 charity).

The Commission has received and reviewed the pertinent records and supporting documentation concerning Tampa Bay Downs' amended application for a pari-mutuel wagering operating license for the 2024-2025 Fiscal Year and after proper consideration thereof,

NOW, THEREFORE, be it known that:

Pursuant to the requirements of section 550.01215, Florida Statutes, the Commission hereby approves this amendment to Tampa Bay Downs, Inc.'s pari-mutuel wagering operating license for the 2024-2025 Fiscal Year.

It is so ordered.


NOTICE OF RIGHT TO JUDICIAL REVIEW

THE NOTICE OF APPEAL MUST BE FILED WITHIN THIRTY (30) DAYS OF RENDITION OF THE ORDER TO BE REVIEWED.
