

**FINAL ORDER APPROVING AMENDMENT TO CARDROOM LICENSE**

Pursuant to the provisions of section 849.086, Florida Statutes, and the rules promulgated thereunder, the Florida Gaming Control Commission ("Commission") is responsible for the investigation and prior approval of applications and amendments to applications for cardrooms; and

PPI, Inc. d/b/a Harrah's Pompano Beach ("Harrah's") possesses a harness permit, permit number 430. Harrah's has been issued a pari-mutuel wagering operating license and a cardroom license for the 2024-2025 Fiscal Year. Harrah's is currently licensed to operate 54 card tables and is requesting permission to add 6 card tables to its cardroom for a total of 60 tables. Harrah's has paid the \$6,000 license fee associated with the additional tables.

The Commission has received and reviewed the pertinent records and supporting documentation concerning Harrah's amended application for a cardroom license and after proper consideration thereof,

**NOW, THEREFORE**, be it known that:

Pursuant to the requirements of section 849.086, Florida Statutes, the Commission hereby approves this amendment to PPI, Inc. d/b/a Harrah's Pompano Beach cardroom license.

THE NOTICE OF APPEAL MUST BE FILED WITHIN THIRTY (30) DAYS OF RENDITION OF THE ORDER TO BE REVIEWED.
