Florida Standardbred Breeders' & Owners' Association, Inc. ("FSBOA") possesses a nonwagering harness permit, permit number 601, and was issued a nonwagering horse racing license for the 2024 Calendar Year. FSBOA submitted a complete application to extend its annual nonwagering horse racing license through the 2024-2025 Fiscal Year.


